

YVEDDI Head Start Annual Report 2011-2012



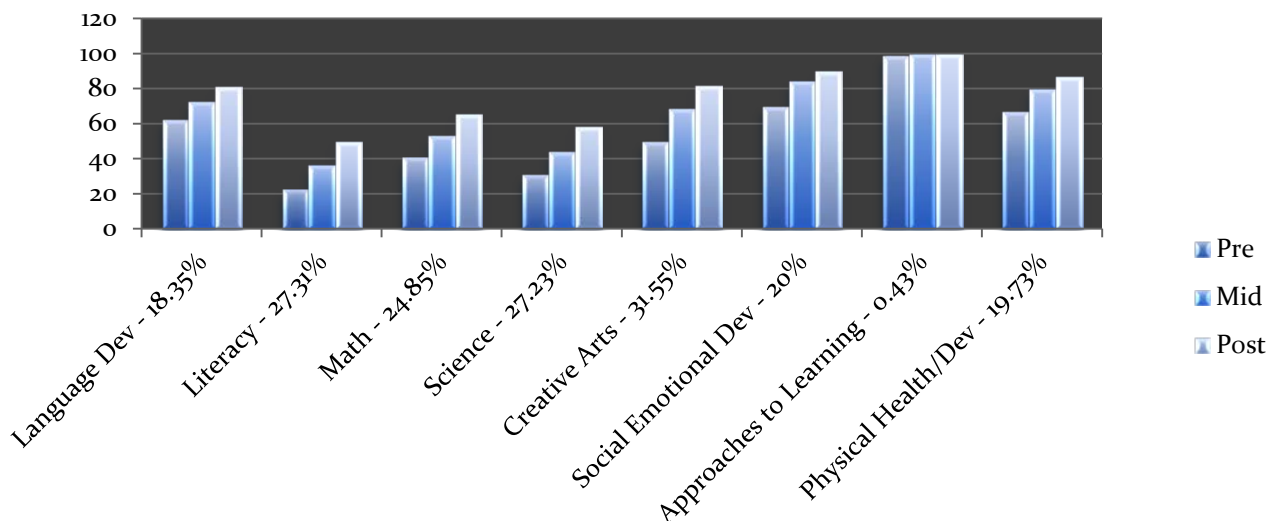
In 22 classrooms and 15 sites Head Start serves 385 children ages 3-5 years to prepare them for Kindergarten and works with families to promote self-sufficiency. Comprehensive services are provided to include child medical and dental services, individualized family services, and transportation as feasible. Operational hours are 8:00 AM – 2:30 PM, Monday through Friday. All services are free for families who qualify. Number of children served by county: Davie-52, Stokes-66, Surry-177, Yadkin-90.

By having a detailed outcomes plan and implementing each part, we are able to form a strategy for each child's development process. Our School Readiness Team reviews and evaluates our outcomes to determine any needed changes in order to ensure optimal school readiness for each child.
