Nutritionally balanced noon-time meals are delivered five (5) days a week, Monday - Friday to eligible homebound persons 60 years of age and older.

The meals are provided to help maintain or improve the health of impaired older persons to enable them to stay in their own homes for as long as possible.

Meals are delivered by volunteers who are reimbursed for use of their personal vehicle.
