We are pleased to present the 2018-19 Annual Report of the Yadkin Valley Economic Development District, Incorporated (YVEDDI). This report will showcase the work and outcomes achieved by a very dedicated staff under the leadership of a very engaged and supportive Board of Directors.

We remain committed to expand our resources however possible to meet the needs of our communities. Upon close of fiscal year June 30, 2019, we helped:

- 451 young children get a Head Start in preparation for Kindergarten,
- 2,191 victims of abuse get a new start,
- 19 people developed life skills and enhance employability to earn a self-sustaining income and 23 are still progressing towards their goals,
- Modified 100 homes to keep 230 people warm in the winter and conserve energy,
- Jones Family Resource Center had 91,544 people in cumulative attendance,
- Promoted senior wellness to prolong independence by:
 - delivering 60,458 homebound meals,
 - served 22,898 congregate meals,
 - provided 14,594 medical and general transportation trips,
 - provided legal assistance to 176 seniors,
 - 4,602 attended 5 senior centers; providing 53,006 services,
 - 200 seniors volunteered 20,563 hours in their communities, and
- Made over 122,953 trips to transport people to school, work, or medical appointments to carry out essential daily living

COMMUNTIY SERVICES PROGRAM (CSBG)

MISSION STATEMENT

To build self-sufficiency for under-resourced individuals and families through coaching, mentoring and community partnerships.

Community Services Block Grant was created by federal legislation to assist low income individuals and families in the early 1980's. It is a Self-Sufficiency Program which is designed to assist individuals/families in overcoming poverty to become self-reliant. We assist participants in gaining employment, obtaining a higher education, resume writing, learning good interview techniques, gaining employment, and learning how to empower themselves in the process of becoming self-reliant. Participants are required to take budgeting classes before services can be provided. Participants pursue goals such as employment, education, transportation, health, housing, and they participate in workshops that we provide. The workshop is called Getting Ahead and is part of the Bridges Out of Poverty curriculum.


Who is living in deep poverty?

We consider CSBG to be a bridge out of poverty. We work with under resourced individuals and families with services to assist them in creating a better future. Each participant's situation is different, but they must be willing and able to work, ready to take the steps to further their education or gain skills to procure a living wage job, set goals, and work closely with the Success Coach.

Collaboration with other community partners is vital to the CSBG Program providing well rounded and comprehensive services to individuals in the communities we serve.

Success Story

Emily has a Bachelor in Nursing from UNC Greensboro and worked as a nurse. Emily was diagnosed with a rare condition leaving her no choice but to step aside from a successful career. Emily enrolled in the CSBG program in the late spring of 2018. During her time recovering from injuries sustained in a car accident, as well as being diagnosed with a rare illness, her husband abandoned her and her two young boys, which forced Emily to move to her parents' home. Emily came to CSBG through a referral by our Head Start advocate. We developed a personalized Action Plan. The Success Coach reached out to various organizations, which assisted Emily to obtain her own housing, file for partial disability, obtain employment as a CNA instructor for a local community college, file for divorce, and obtain child support payments. Emily managed her income, her divorce became final, her housing stable, Emily's health is being maintained, and the community college placed her as the lead instructor. Emily thrived, moved forward and graduated successfully from CSBG in the Spring of 2019.

When our Success Coach left her position in Stokes County, Emily applied for the position when it was posted. Emily interviewed and having done so well in the program proved to be the perfect candidate for the part time position that was offered. She was employed and worked several months as a Success Coach. Unfortunately, for us, but great for Emily, she proved to herself that she was ready for full time employment and obtained a job as Health Coordinator for Forsyth County. We are pleased that she has achieved success!



DOMESTIC VIOLENCE/ SEXUAL ASSAULT PROGRAM

MISSION STATEMENT

To provide safety, supportive services and advocacy for victims of domestic violence and sexual assaul t.

The YVEDDI Stokes, Surry, Yadkin Domestic Violence/Sexual Assault Program Services want to end the cycle of violence. The major focus of our services is to provide emergency services and assistance to those who have been victimized by domestic violence and sexual assault. In the fiscal year July 1, 2018--June 30, 2019, Stokes, Surry, and Yadkin DV/SA advocates provided direct services to 2,125 unduplicated individuals. Staff responded to 7,762 crisis calls, offered 168 peer support groups, and provided emergency transportation to 62 victims.

One of our top priorities is to raise awareness of Domestic Violence and Sexual Assault in our counties; otherwise, people do not know that these issues exist in our communities, if people don't know where to turn for help the cycle will continue. Awareness and education are the two strongest tools we have to make a better tomorrow for victims and potential victims. Stokes, Surry, and Yadkin DV/SA advocates provided community education and outreach to approximately 5,500 adults and youth last year. The program has increased efforts to strengthen collaboration between community partners in the rural area.

43.9% of North Carolina women and 19.3% of North Carolina men experience intimate partner physical violence, intimate partner sexual assault violence and/or intimate partner stalking in their lifetimes.

Success Story

A young lady came into our office with a DSS caseworker requesting help with a Domestic Violence Protection Order. Abuse had been reported by her 7 year old son to his school counselor, who called DSS. The mother had been to our office several times in the past for hours discussing her home life and that she was making preparations to leave her children's father, but was too scared. She stated she thought the counselor calling DSS was the best way for it to be reported. She was walking away from everything she had built with the children's father in the past 7 years and start fresh. Over the course of the 7 years, she had been through severe physical, emotional, verbal and financial abuse. Our staff took notice of obvious side effects of high levels of stress that caused hives she was scratching deep into her skin on her arms, stuttering, she couldn't focus and she had severe anxiety. Her abuser made her think she would have a mental breakdown. She stated he got her addicted to prescription medication and she began abusing it due to the abuse. Staff started helping her with the paperwork for the protection order. We found her a shelter as close by as possible and told her she would have to come back Monday to go before the Judge. The Magistrate granted her Ex Parte for the weekend and the DSS caseworker took her along with law enforcement to retrieve a few of their belongings. During the process of her ongoing case, we have gone to court with her. We have given her food and gas cards to help her and the children and have made the appropriate referrals to seek additional services. Since living in the shelter, she has enrolled her two small children in elementary and preschool and she has gotten a full time job along with a part time seasonal job. She is in the process of finding a home that she can afford and a reliable vehicle. Our staff has told her we are here for her and the children. Our staff has seen the biggest difference in this young lady's life from the first time she came into our office. Since leaving her abuser, she always has a smile on her face and something positive to say, she praises our office staff every time she sees us or talks to us. We have a special bond with this client because she has never given up and pressed forward for her and her children. We are very thankful to have met her and hope to keep in contact with her.

The Senior Centers provide services to help keep seniors active and healthy so they are able to maintain their independence in their own home as long as possible.

- Transportation Services
- Public Benefits Counseling

- Educational and Arts Programs
- Intergenerational Programs

Senior centers are a place for seniors to come for nutrition, fun, fellowship, and most importantly, to combat social isolation and loneliness. Many senior center participants are widows and widowers.

Impact in the Community

 The Senior Centers provided a combined 53,006 services to seniors age 50+.

Some of those services include Matter of Balance classes, new exercise equipment, exercise classes at no charge to the seniors, day trips, Senior Games, art classes and outreach events in the community that reach more than 200+ people at a time.

Today's senior centers are reinventing themselves to meet the needs and desires of the aging baby boom generation. Boomers now constitute more than two-thirds of the 50+ population. Senior centers are developing new programs and opportunities for this dynamic generation of older adults.

Some were crocheting, some were at the puzzle table, and they were all talking about the activities we have going on at the center. Mrs. W. said that before she started coming here she would get up around 9 each morning, put her housecoat on over her nightgown, and at night she'd take her housecoat off and go to bed. She said now she tells everyone they need to come to the center. She looks forward to getting up each morning, getting dressed, and coming to the center. She comes most everyday now, and on Wednesday nights her children all call her to see if she won at bingo. She is so glad she started coming to the center.

Aging In North Carolina...

In the next two decades, our 65 and over population will increase from 1.6 to 2.6 million, a projected growth of 64%. The projected growth among the age groups 65-74 (38%), 75-84 (100%) and 85+ (111%) indicates that as the baby boomers continue to age, there will be an increased proportion of older adults in the state creating challenges for long-term services and supports.

STATISTICS

Nearly 11,000 senior centers serve 1 million older adults aged 50+ every day.

Approximately 70% of senior center participants are women; half of them live alone. Three-quarters visit their center one to three times per week and spend an average of 3.3 hours per visit.

The average age of participants is 75.

Research shows that compared with their peers, senior center participants have higher levels of health, social interaction, and life satisfaction.

Senior hunger and nutrition are significant issues in the U.S., with more than 10 million older Americans at risk of hunger and about 10% of adults experiencing malnutrition.

Did you know?

- All YVEDDI nutrition sites are inspected and graded by the local health departments, just like a restaurant? All sites maintain a Grade A.
- YVEDDI-Senior Services successfully completed the 2019 Operation Fan Heat Relief Program in Yadkin county. 13 fans were purchased and distributed to seniors in Yadkin County with grant funding from Duke Energy, Dominion Resources, and Valassis.
- YVEDDI-Senior Services successfully completed the 2019 N.C. Senior Farmer's Market Nutrition Program, distributing 1,000 vouchers, worth \$3 each, to seniors in Surry and Yadkin counties. The program requires each eligible senior to receive 8 vouchers. This enabled 125 seniors to purchase \$24 worth of fresh produce each at farmer's markets, thereby enhancing their access to fresh, nutritious locally-sourced produce; adding \$3,000 into the local economy.
- YVEDDI-Senior Services staff successfully conducted fundraisers that added more than \$25,000 in additional funding to senior programs.
- YVEDDI-Senior Services volunteers contributed 16,372 hours of volunteerism to delivering meals and assisting site managers with serving congregate meals. This is a value of \$416,340! (Based on the Federal 2019 rate at \$25.43/hour from independent sector org.)
- Recent grantor monitoring concluded with only one (1) finding, out of hundreds of compliance measures.

RETIRED SENIOR VOLUNTEER PROGRAM (RSVP)

RSVP is one of the largest volunteer networks in the nation for people ages 55 and older. The RSVP Program gives seniors an opportunity to use their talents and the skills they've learned over the years and even develop new ones while serving in a variety of volunteer activities within their communities.

In 22 classrooms and 15 sites, Head Start serves 385 children ages 3-5 years to prepare them for Kindergarten and works with families to promote self-sufficiency. Comprehensive services are provided to include child medical and dental services, individualized family services and transportation, as feasible.

Operational hours are 8:00 AM – 2:30 PM, Monday through Friday. All services are free for families who qualify.



CHILD OUTCOMES

Three times per year we assess and report on each child's progress in the Head Start program. In summary, our goal is to find out what the children already know and use our assessment to help them become "School Ready". By having a detailed outcomes plan and implementing each part, we are able to form a strategy for each child's development process.



SCHOOL READINESS INITIATIVE

In order to ensure school readiness for children, YVEDDI Head Start developed a School Readiness Committee.

The following statement is the Mission Statement of the committee:

YVEDDI Head Start will establish and carry out program goals for school readiness in accordance with the Head Start Child Outcomes Framework. The goals will be shared throughout all components of the program, with Head Start parents and our LEAs in order to ensure school readiness success for all Head Start children and their families.

YVEDDI HEAD START READINESS PLAN OVERVIEW

YVEDDI Head Start has aligned our readiness goals with the North Carolina Foundations for Early Learning and Development and Teaching Strategies Gold Objectives for Development and Learning – Birth through Kindergarten Assessment Tool. (Early Learning Strategies for NC Preschoolers and Strategies for Guiding Their Success).

North Carolina Foundations describes goals for all children's development and learning, no matter what program they are served in, the language they speak, disability they may have, or their family circumstances. Foundations and Teaching Strategies Gold provide age-appropriate goals for our children and address the domains of learning that we measure through our ongoing assessments.

Data to support the achievement of the goals will be aggregated and analyzed after each child assessment checkpoint, in accordance with our Outcomes Plan. Checkpoints are conducted three times during the academic year. We will use the data gathered to determine our progress towards meeting our Federal Grant Goals, to inform parents and the community of the outcomes and use the information to make the necessary

program improvements to curriculum, teaching and instructional strategies, professional development, and program design and to assist with other program decisions.

The school readiness goals are created in conjunction with parents and we will determine each child's progress in the following domains; approaches to play and learning, emotional; and social development, health and physical development, language development and communication, cognitive development, as well as supporting dual language learners. We will also use the gathered assessment data to individualize services and teaching to best support each child.

YVEDDI Head Start will share our collected school readiness information with the public schools as part of our transition packet for each child. The information will be delivered to the schools and forwarded to the child's kindergarten teacher.

Results of the Most Recent Review by the Secretary

During the 2017-2018 school year, the program underwent two intense reviews from the Administration for Children and Families, a federal agency operated by the Department of Health and Human Services, its primary funding source. The reviews specifically monitored Environmental Health and Safety, School Readiness and the overall delivery of child services. Both reviews resulted in 100% compliance with the 1700+ Federal Performance Standards. In January 2018, the program had a CLASS review. Our scores were 5.9861 out of a possible 7.0 in Emotional Support, 5.5093 out of possible 7.0 in Classroom Organization and 3.1852 out of a possible 7.0 in Instructional Support.

YVEDDI Migrant Head Start has aligned our school readiness goals with the Foundations (Early Learning Strategies for NC Preschoolers and Strategies for Guiding Their Success).

These goals are believed to be age-appropriate for our children and address the domains of learning that we measure through our ongoing assessments.

Data to support the achievement of the goals will be aggregated and analyzed after each child assessment is completed. Assessments are conducted periodically throughout the season for the enrolled children from birth to 5 years of age. The data gathered is used to determine progress made towards meeting our goals, informing parents and the community of the results, and to guide any necessary program improvements to curriculum, teaching, instructional strategies, professional development, program design, and to assist with other program decisions.

The school readiness goals are shared with parents and center staff will determine each child's progress in language and literacy, cognition and general knowledge, approaches to learning, physical well-being and motor development, and social and emotional development. All assessment data gathered will be used to individualize services and teaching to provide the best support to each child.

YVEDDI Migrant Head Start will share collected school readiness information with the public schools as part of our transition packet for the preschool age children transitioning into kindergarten.

Program Description/Purpose: **YVEDDI's** Jones Family Resource Center (JFRC) is a multi-purpose center which addresses various needs of the community. Programs are offered regularly to promote health and wellness, education, recreation, socialization and volunteerism.

The Jones Family Resource Center coordinates and partners with numerous local agencies, colleges, schools, businesses and individuals to offer a variety of services and opportunities that appeal to the interests and needs of the community.

The center is open Monday through Friday from 8:00 a.m. to 4:30 p.m. and has extended operating hours (evenings/ weekends) for programs that are sponsored by JFRC occupants. The center is closed on holidays and weekends.

The Jones Family Resource Center is administered by the Yadkin Valley Economic Development District, Inc.

The Center has two budgets:

- 1) Facilities Funded through the occupants' cost-sharing fees.
- 2) Operations Funded by the County of Surry, fundraisers, community use fees, and general contributions.



- The JFRC began sponsoring a new support group in October 2018. Parents of Addicted Loved Ones helps provide hope through education and support for families of adult children dealing with substance addiction.
- Two new programs now call the JFRC home. The Disabled American Veterans and it's Auxiliary and Faith Deliverance for Jesus #2 relocated to the JFRC in October 2019.
- The JFRC continues to receive in-kind labor through the Urban League program. Three employees stationed at the JFRC work 20 hours per week. They are employed and paid through the Urban League.
- A local church provides two volunteers 3-4 hours a week that help with numerous activities and projects.
- The JFRC was the recipient of a number of in-kind projects from the County of Surry. This saved a substantial amount of money on labor and materials.

Grace's Closet...a Free Community Clothes Closet

Grace's Closet is a free community clothes closet and is located at the L.H. Jones Family Resource Center. It is operated and managed by Yadkin Valley Economic Development District, Inc. (YVEDDI). Grace's Closet is solely funded by community donations and operated by volunteers and one Urban League worker. Grace's Closet would not be able to keep the doors open without our wonderful partners. Yearly, we see the numbers of individuals served continue to grow. We project that the need will only increase during the upcoming year. Below is the monthly/yearly statistics of the services that were provided during the past year.



PUBLIC TRANSPORTATION

YVEDDI Public Transportation is a regional transportation system providing a variety of transit services and programs to groups and individuals in Davie, Stokes, Surry, and Yadkin Counties.

Some of the types of trips provided are: congregate nutrition, special events, and youth activities. Contracted services are available for elementary, developmental and preschool transportation; trips for medical services; shopping for daily living supplies; and transportation to work. Services are available to people with transportation challenges, including the elderly and disabled, veterans, and others. We also operate a rural general public program for a small fee as funding and vehicles are available.

Success Story

While travel training a group of new clients on the newest Circulator route a frequent passenger expressed her appreciation for YVEDDI's Transportation services and their continuous improvements to assist people in the community. She was so grateful for the Circulator and the opportunities that it opened up for her. She now has a full-time job, can run errands regularly throughout the week, and is able to get routine medical attention, which she could not do before because of not having adequate transportation. The Circulator route runs right to her home and throughout the town where she has to go in order to complete her daily living needs. She currently buys a \$3 all-day pass and plans her schedule accordingly, which she says has been a blessing.

As an added bonus the passengers were able to see the experienced driver's skills at his best. There was an unexpected detour and a few of the passengers were afraid that they may be late for work and a medical appointment. The driver assured them not to worry that he had matters under control and that he knew the area very well. The driver was able to adjust the detour to maneuver around the congested traffic and regained his location on the scheduled route and was able to safely deliver the passengers to work and their medical appointment with time to spare.

The group of new passengers began to get more comfortable with the idea of using public transportation and became excited about riding in the immediate future. The Mobility Manager provided all of the riders with extra printed schedules and brochures so they could share with others that were skeptical about using the new service. The passengers were very impressed and were confident that they were in great hands. Once the travel training tour was over the grouped expressed their appreciation for the experience, promised to tell others, and were looking forwarding to riding again.



WEATHERIZATION PROGRAM

MISSION STATEMENT

To provide home energy improvements using state standards that promote good health and energy efficiency.

Weatherization Assistance Program

The Weatherization Assistance Program, operated by Yadkin Valley Economic Development District, Inc. (YVEDDI), is designed to help low-income households, particularly the elderly and the disabled, overcome the high cost of energy, through the installation of weatherization or energy conservation measures.

The NC Department of Environmental Quality has designated funds to assist qualifying families and individuals to make their homes more energy efficient and to help reduce the cost of their utilities. Weatherization includes sealing air leaks, installing insulation and performing other measures that will reduce energy usage the home. Funds have also been set aside to form a program that assists qualifying households to repair or replace an existing heating system or to provide an adequate heating system where none exists.

To meet the financial requirements for this assistance, the gross household income for the last 12 months cannot exceed 200% of the Federal Poverty Index. The labor and materials for these services are free of charge to owner-occupied homes.

The Heating and Air Repair and Replacement Program (HARRP)
Repairs or replaces heating and cooling systems for low-income households.

Heating and Air Repair/Replacement Program

The Heating and Air Repair/Replacement Program (HARRP) is another part of the Weatherization Program for low -income households. HARRP's purpose is repair or replace heating systems that are functioning below the manufacturer's standards or to install a new system where there is no adequate heat source. In Fiscal Year 2018-2019, 27 heating systems were repaired or replaced, making a difference in the lives of 67 people.

Success Story

Rowan County

We replaced a client's outdated non-

functioning HVAC unit under the State HARRP Program; we weatherized her home under the Duke Energy Program; replaced her floor where it was caving in, and built a wheelchair ramp for her son under the Blue Cross Blue Shield Program.

The client stated she was "very thankful for all our help, I can never say thank you enough.

Your workers were so polite and very professional in every way.

The ramp has changed my son's life, where he is wheelchair bound and with the new ramps, he can get in and out of our home.

This program has went above and beyond anything I could have ever imaged."


