YVEDDI By-Laws: Public Officials or their representatives may be replaced on the Board only by the respective Boards of county commissioners which appoint them

Yadkin Counties. (Ref.10A NCAC 97C.0109 NC Department of Health and Human Services). Tripartite: The YVEDDI Board shall consist of 1/3 members from the public sector, 1/3 from the low-income sector, and 1/3 private sector from the areas of Davie, Stokes, Surry, and

- 1/3 public officials serve as ambassadors of good will to the public, bring expertise in public relations, meetings, administration, funding, and fiscal affairs
- 1/3 representative of low-income because they know the problems of poverty; must live in service area but does not have to be low-income themselves
- 1/3 private-sector serve as the balance of the community and they can provide other resources or specialized business expertise
- Committees are balanced by groups (sectors) and counties to the extent possible
- Membership must be divisible by 3
- Membership total 24
