**YVEDDI By-Laws:** Public Officials or their representatives may be replaced on the Board only by the respective Boards of county commissioners which appoint them

**Tripartite:** The YVEDDI Board shall consist of 1/3 members from the public sector, 1/3 from the low-income sector, and 1/3 private sector from the areas of Davie, Stokes, Surry, and Yadkin Counties. (Ref: 10A NCAC 97C.0109 NC Department of Health and Human Services).

- 1/3 public officials serve as ambassadors of good will to the public, bring expertise in public relations, meetings, administration, funding, and fiscal affairs
- 1/3 representative of low-income because they know the problems of poverty; must live in service area but does not have to be low-income themselves
- 1/3 private-sector serve as the balance of the community and they can provide other resources or specialized business expertise
- Committees are balanced by groups (sectors) and counties to the extent possible
- Membership must be divisible by 3
- Membership total - 24
